- Al punto di ingresso in territorio nazionale, o comunque entro i 5 giorni successivi dall'ingresso, verrà garantita:
  - la somministrazione dei vaccini anti Covid-19, difterite, tetano, pertosse, poliomielite
  - l'offerta del vaccino anti morbillo, parotite, rosolia e del test di screening per la tubercolosi, ed a valutazione delle autorità sanitarie, anche di altre vaccinazioni.
- Fino al 31 marzo 2022, nelle more dell'emissione del certificato verde cosiddetto "rafforzato", sei autorizzato a permanere nei centri di accoglienza, nel Sistema di accoglienza e integrazione (SAI) o nelle altre strutture ricettive ove sarai ospitato o presso le abitazioni private messe a disposizione.

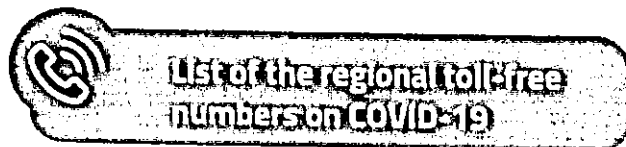

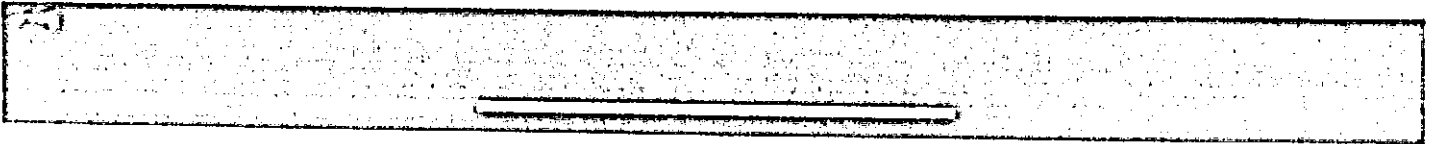

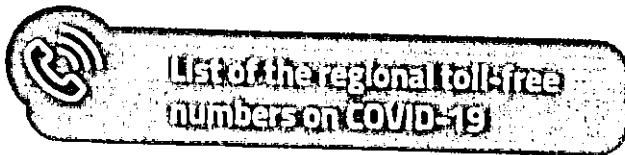
